Thank you for your e-mail. I spoke to our Transportation team and it appears the future THPRD multi-use trail would run along the east-west portion of SW Westgate Drive (shown by the pale pink dotted line in the image below; apologies, it's a bit hard to see) and doesn't directly abut this project site (identified by the red circle in the image below). However, the applicant is proposing to provide a pathway along Beaverton Creek, as shown on the 2nd and 3rd pages of the attached landscaping plans. There is potential for this pathway to be expanded in the future, but the developer is not required to construct more than what is shown on the plans at this time. I'd also like to note the developer will be required to construct sidewalks and bicycle lanes along both the SW Hall Boulevard and SW Westgate Drive frontages for this project.
