  - a. A physical obstacle such as topography or natural feature exists and prevents the full implementation of the applicable standard; or
  - b. The location of existing structural improvements prevent the full implementation of the applicable standard; or

A physical obstacle such as topography or natural feature exists and prevents the ful implementation of the applicable guideline; or  b. The location of existing structural improvements prevent the full implementation of the applicable guideline; or  c. The location of the existing structure to be modified is more than 300 feet from a public street.
