SETTING: The Robinson Resjidence and Beaverton Bakery are situated on the north sjde of SW Broadway Street at the edge of the old downtown area. SW Hall Street is to the west.

STATEMENT OF SIGNIFICANCE (Historical and/or architectural importance, dates, events, persons, contexts). This builoing was the resjdence of Doctor Francis Marjon Robjnson, who practiced medjcine for almost 30 years in the Beaverton area. Jr. Robinson was born in Hillsboro, Oregon jn 1848. He studjed medicine at willamette Unjversjty and graduated from the Department of Medjejne in 1885. One year later he started a medjcal practice in Beaverton and soon thereafter settled into this house on SW Broadway Street which was constructed for him jn 1887. He marrjed Lottje genis from Wisconsin jn 1889, anc they had three children. In addjtjon to bejna a pronnent doctor in Beaverton, Mr. Robjnson served as City Councilman and was mayor of the town $101903,1904,1905,1907$ and 1910 . Durjng his tenure he held City Council meetings at his offjce. In 1906 he recejved a $\$ 10$ warrant for his kjndness and for holdjng Councjl meetings at his office. Robjnson also served as the town's first Health officer, servjng jn that posjtion jn 1907 and again in 1915. He djed at his home in 1915 at the age of 67 .

The house is the best example of the Queen Anne style in the city of Beaverton. The rjchly ornamented buildjing with jts full hejght polygonal bay window, decorative frjeze and spindle work, has retajned jts integrjty in an area that has seen sjonjfjcant development pressures. It has been successfully converted to a commercjal use. The one story commercjal attachment, which dates from 1925 was orjginally the pharmacy. It js a fine example of this bujldjng type. The decorative brjckwork is of partjcular note. The pharmacy was operated by Mrs. Robjnson.

Signifjcant: Indjvjdually the jmportant bujldings, sjtes, structures or objects in Beaverton distjnguished by outstanding aualitjes of architecture, relatjonshjp to envjroment and/or historjc assocjatjons.

Important: Bujidjngs, sjes, structures or objects, which are not of outstandings distjnctiveness or varjety, in terms of architecture or historic assocjation andor relationshid to environment, but have sufficjent sjonjfjcance to make them worthy of preservation.

Contributing: Bujldjngs, sites, structures or objects, which are less sjonjfjcant examoles of archjtecture or of lesser historjcal assocjatjon. They may also provjoe the contexts for more sjonjfjcant resources.

Unrankable: These resources lack suffjcjent informatjon to be ranked. When that information is avajlable, those found to be Sjonjfjcant or ImDortant shall be recommended by the HRRN for desjonation as Landmarks.
