This memo addresses the preliminary staff comments identified by the Facilities Review Committee for the Design Review III application submitted by Pacific Community Design, Inc. on behalf of Fred Gast of West End Beaverton, LLC to modify the conditions of approval for West End District Design Review III application DR2018-0149. Explanations are provided below on how each incomplete item is addressed:
