The matter came before the Planning Commission on February 7, 2018, on a request for a Comprehensive Plan Land Use Map Amendment to adjust the boundaries of the land use districts within the development area to align with the proposed development. The site is located north of SW Scholls Ferry Road at SW Strobel Road. Address: 18485 SW Scholls Ferry Road. Tax Lots 301 and 302 on Washington County Tax Assessor's Map 2S10600.

Pursuant to Ordinance 2050 (Development Code) Section 50.45, the Planning Commission conducted a public hearing; reviewed exhibits; and considered testimony on the subject proposal.

The Commission, after holding the public hearing and considering all oral and written testimony, adopts the Staff Report dated January 31, 2018, and the findings contained therein, as applicable to the approval criteria contained in Section 1.5 of the Comprehensive Plan.

Therefore, **IT IS HEREBY ORDERED** that **CPA2017-0007** is **RECOMMENDED FOR APPROVAL** to the City Council, based on the testimony, reports and exhibits, and evidence presented during the public hearing on the matter and based on the facts, findings, and conclusions found in the Staff Report dated January 31, 2018 and the findings contained therein. No conditions of approval.


