The amendments affect Volume I (Chapter 1 – Procedures; Chapter 3 – Land Use; Chapter 5 – Public Facilities and Services; Chapter 6 – Transportation; Chapter 7 – Natural, Cultural, Historic, Scenic, Energy, and Groundwater Resources; and Chapter 8 – Environmental Quality and Safety), Volume III (Statewide Planning Goal Five Resource Inventory), Volume IV (Transportation System Plan, including Chapters 2 and 4 and Appendices O and P), and Volume V (Community Plans).

Pursuant to Beaverton Comprehensive Plan Section 1.6, the Planning Commission conducted a public hearing and considered testimony and evidence on the subject proposal.

Chair McCann then closed the public hearing, and Vice Chair Winter made a motion to approve the proposed amendments. Commissioner Lawler seconded the motion. The Commission, after holding the public hearing and
