The matter came before the Planning Commission on August 24, 2022, on a request for a Parking Determination for a new public park and to provide no on-site vehicle parking and four short-term bicycle parking spaces. The site is located at the southwest corner of SW Barrows Road and SW Bittern Terrace, specifically identified as a 2.63-acre portion of Tax Lot 103 on Washington County Tax Assessor’s Map 2S10600.

Pursuant to Ordinance 2050 (Development Code) Section 50.45, the Planning Commission conducted a public hearing and considered testimony and exhibits on the subject proposal.

The Commission, after holding the public hearing and considering all oral and written testimony, adopts the Staff Report dated August 17, 2022, and the Supplemental Memorandum dated August 24, 2022, and the findings contained therein, as applicable to the approval criteria contained in Section 40.55.15.1 of the Development Code.

Therefore, **IT IS HEREBY ORDERED** that **PD2022-0002** is **APPROVED**, based on the testimony, reports and exhibits, and evidence presented during the public hearing on the matter and based on the facts, findings, and conclusions found in the Staff Report dated August 17, 2022, and

the Supplemental Memorandum dated August 24, 2022, and the findings contained therein, subject to the conditions of approval as follows:

A. General Conditions, the applicant shall:

1. Ensure that the New Conditional Use (CU2022-0005) and Design Review Three (DR2022-0047) applications have been approved and are consistent with the submitted plans. (Planning / BG)
