The City Council meeting will be held in the Council Chambers at the Beaverton Building located at 12725 SW Millikan Way, Beaverton, Oregon. This annexation request will be considered as part of the Council's Agenda and is described as follows:

ANX2019-0004, 10270 SW PARK WAY ANNEXATION

Ordinance Annexing Two Parcels of Land Located at 10270 SW Park Way and right-of-way adjacent to the properties; withdrawing the properties from the Tualatin Valley Water District, the Washington County Enhanced Sheriff's Patrol District and the Washington County Urban Road Maintenance District; and adding the properties to the Central Beaverton Neighborhood Association Committee. The subject properties are identified as tax lots 1S102CC02800 and 1S102CC02900. The properties are identified as tax lots 02800 and 02900 on Washington County's Tax Assessors tax map 1S102CC.

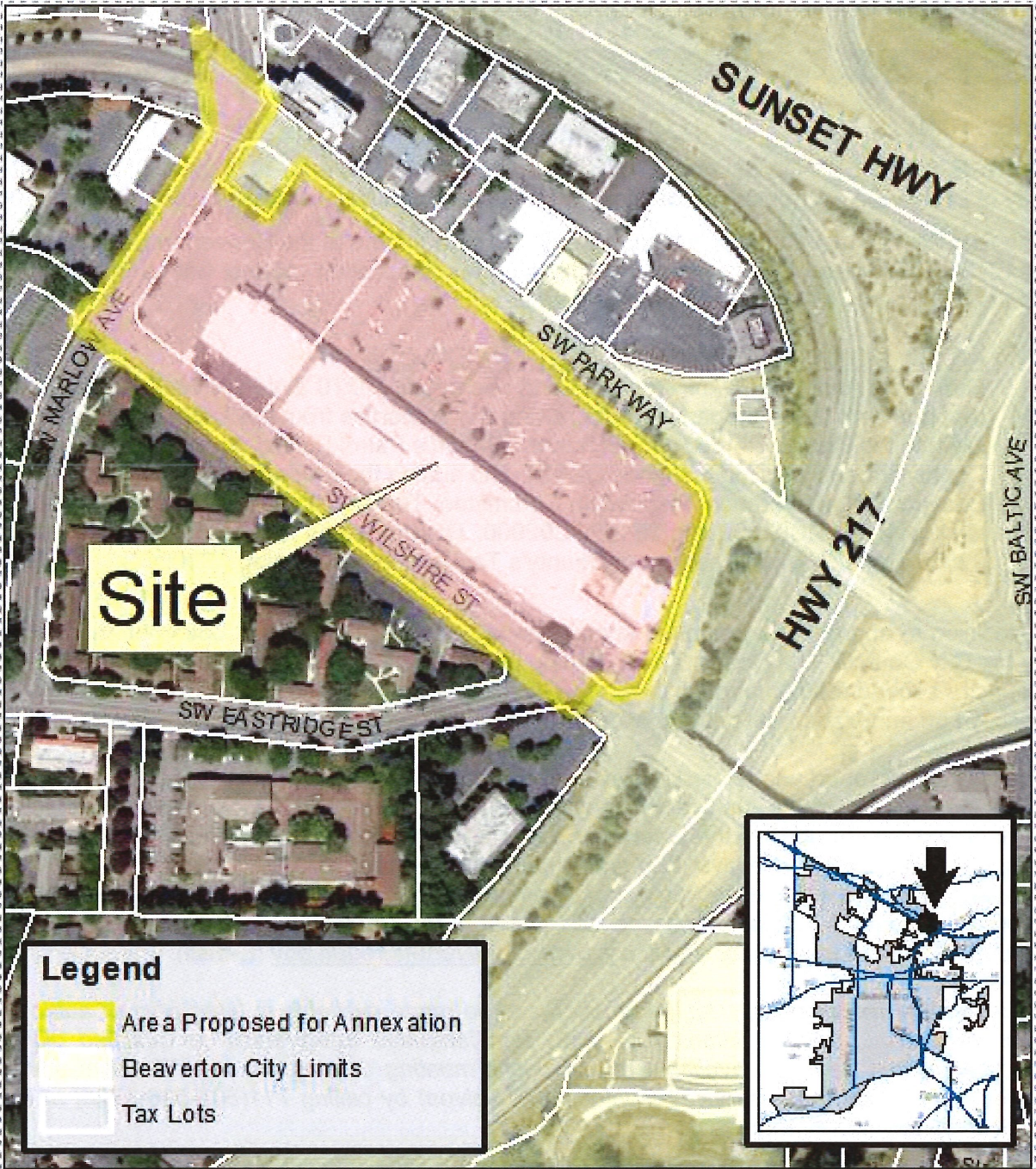
A decision to approve the proposed annexation will occur through the adoption of an ordinance by the City Council. The Council's first reading of the ordinance will occur on June 4, 2019. The Council's second reading and decision regarding adoption, is scheduled for June 11, 2019. The decision on annexation will not authorize or prevent any specific use of land.
