Summary of Application:

The applicant, Tualatin Hills Park and Recreation, requests approval for Design Review Three, Conditional Use for a public park in a Residential Zone, and Tree Plan Type 2 application for the reconstruction of Cedar Hills Park, with the removal of some trees from Significant Grove G37. Physical improvements include a lighted sport field, splash pad, community gardens, playgrounds, lighted sport courts, picnic shelters, restrooms, and surface parking.

Project Location:

The site is located North of SW Walker Road and east of SW Cedar Hills Boulevard; Tax Lot 10500 on Washington County Tax Assessor's Map 1S110BB, and Tax Lot 12000 on Washington County Tax Assessor's Map 1S110BC.

The Director will include the Committee's recommendation in the staff report to the decision-making authority. The Facilities Review Committee meeting is open to the public, but is not intended for public testimony.

A copy of the pre-application conference notes, neighborhood meeting information, and all other documents and evidence submitted by or on behalf of the applicant, and applicable review criteria, are available for inspection at the Beaverton Planning Division, 4th floor, Beaverton Building, 12725 SW Millikan Way, between the hours of 7:30 a.m. and 4:30 p.m. Monday through Friday, except holidays. The Planning Commission shall conduct hearings in accordance with adopted rules of procedure and shall make a decision on the development application after the hearing closes. Failure to raise an issue in a hearing, by testifying in person or by letter, or failure to provide statements or evidence with sufficient specificity to afford the decision-making authority an opportunity to respond to such issue, may preclude appeal to the Land Use Board of Appeals on that issue.
