Summary of The applicant, 3J Consulting on behalf of Washington County, is Application: Seeking time extensions for the following decisions: PTF2019-0001,

SDM2019-0002, TP2019-0002 and DR2019-0063. The original expiration date for the project was September 11, 2023. This is the first extension request for the project. If approved, the time extensions would extend the expiration date for the Public Transportation Facility, Sidewalk Design Modification, Tree Plan and Design Review applications to September 11, 2025.
