The FCC requires the City to act on small cell permit applications without a public hearing, which includes any administrative appeals, in 60 days for attachments to existing structures and 90 days for new structures, unless the applicant voluntarily agrees to toll the timeframe for review. This Notice is mailed within seven (7) calendar days after the submittal package is deemed complete. The comment closing date is as stated above per SWF policy 2.4.a.1.F and G.

Staff strongly encourages you to submit any testimony comments or questions via email or mail to the plan reviewer named above. Please reference the Project Name and Permit Number as stated above in your written comments. Failure to provide statements or evidence that evaluate the application for compliance with the applicable criteria in Section 2.4.c and standards in Section 2.6, Section 2.7 and Section 3 that would allow the City an opportunity to respond to such issue, may preclude appeal to the City Manager on that issue. Written comments may be mailed to the Attn: Site Development Division, at PO Box 4755, Beaverton, OR 97076. Written comments, either emailed or mailed, on the above proposal must be received no later than 5:00 p.m. on July 12, 2024, which is within 28 calendar days from the date application was deemed complete

Per policy SWF Section 2.4.e, the Director is the decision-making authority for the above application and shall issue a written permit decision on the above proposal within 5 calendar days after the administrative review decision. Copy of the permit decision will be made available on the City's website <https://apps2.beavertonoregon.gov/DevelopmentProjects/notices.aspx> or may be provided by the plan reviewer upon request.
