Summary of Application:	The applicant, Organic Milk Exchange, requests Design Review Two approval to redevelop an existing industrial site. Site improvements include a 5,910 square-foot addition to an existing industrial building, improvements to landscaping and pedestrian circulation areas, and improvements to vehicle parking, maneuvering, and circulation areas. The proposal includes a Parking Determination application to address the unique combination of manufacturing and cold storage uses proposed. The proposal also includes a Sidewalk Design Modification to vary from Collector Street standards for a portion of the site along SW 5 th Street.
Project Location:	The site is located at 5051 SW Western Avenue, specifically identified as Tax Lots 200 and 300 on Washington County Tax Assessor's Map 1S114CB.

The Facilities Review Committee is not a decision-making body but advises the Director on a project's conformity to the technical criteria specified in Section 40.03.1 of the Beaverton Development Code. The Facilities Review Committee meeting is open to the public but is not intended for public testimony.

The Director is the decision-making authority for the above application and shall issue a written decision on the above development proposal on or around February 22, 2023, pursuant to Section 50.40.10.
