Summary of Application:	The applicant, PJN Holdings, LLC, requests Design Review Two approval to demolish an existing single-story dental office building and construct a new, approximately 8,550 sq. ft., two-story office building. The new office building will include an office use on the main floor and a dental office on the upper level. Site improvements include parking area redevelopment, a garbage/recycling enclosure, site lighting, and landscaping. A Loading Determination is requested to vary from the loading berth standards. The applicant proposes to use a standard parking stall for on-site deliveries.
Project Location:	The site is located at 8900 SW Hall Boulevard, specifically identified as Tax Lots 600 on Washington County Tax Assessor's Map 1S126BC.

The Facilities Review Committee is not a decision-making body but advises the Director on a project's conformity to the technical criteria specified in Section 40.03.1 of the Beaverton Development Code. The Facilities Review Committee meeting is open to the public but is not intended for public testimony.

The Director is the decision-making authority for the above application and shall issue a written decision on the above development proposal on or around August 9, 2023, pursuant to Section 50.40.10.
