Project Name:	Pacific Avenue Apartment Mods
Case File No.:	DDR2023-0005
Summary of Application:	The applicant, New London West, LLC, requests Downtown Design Review Two approval to construct a multi-dwelling apartment building with twelve (12) attached residential units, one live/work unit and a community room. The proposal will remove the previously approved tuck-under parking associated with approved casefile DDR2022-0010, close vehicular access from SW Pacific Avenue, increase the total units from nine to thirteen and improve the frontage of the site with a ten-foot sidewalk.
Project Location:	The site is located at 4920 SW Pacific Avenue, specifically identified as Tax Lot 00200 on Washington County Assessor's Map 1S115CA.

The Facilities Review Committee is not a decision-making body but advises the Director on a project's conformity to the technical criteria specified in Section 40.03.1 of the Beaverton Development Code. The Facilities Review Committee meeting is open to the public but is not intended for public testimony.

The Director is the decision-making authority for the above application and shall issue a written decision on the above development proposal on or around May 24, 2023, pursuant to Section 50.40.10.
