

NOTICE OF PROPOSED ANNEXATION TO THE CITY OF BEAVERTON

NOTICE IS HEREBY GIVEN that at **6:00 PM on TUESDAY, August 16, 2022**, the City Council of the City of Beaverton will consider a petition to annex 11375 and 11475 SW Walker Road.

The City Council meeting will be held in the Council Chambers at the Beaverton Building at 12725 SW Millikan Way, Beaverton, Oregon. **Note: The meeting will be held remotely** and can be viewed at the following link: <https://beavertonoregon.gov/797/Agendas-Minutes>. This annexation request will be considered as part of the Council's agenda and is described as follows:

ANX2022-0002 WALKER ROAD ANNEXATION

An ordinance annexing properties at 11375 and 11475 SW Walker Road; withdrawing the properties from the Tualatin Valley Water District, Washington County Enhanced Sheriff's Patrol District, and Washington County Urban Road Maintenance District; and adding the properties to the Central Beaverton Neighborhood Association Committee

A decision to approve the proposed annexation will occur through the adoption of an ordinance by the City Council. The Council will announce the hearing on July 19, 2022. The Council will hold a hearing and take action on August 16, 2022. The petition is subject to the expedited process unless a necessary party gives written notice of its objection to the boundary change. The decision on annexation will not authorize or prevent any specific use of land.
