Please enter the following as testimony on the record for the hearing on Tualatin Hills Park and Recreation's proposal
Project LU32023-00667 Pointer Rd Park at 7360 SW Pointer Road:

Attached are recent photos of the Pointer Road Park property greenspace which borders my property at 7430 W Pointer

Currently, neighbors with their dogs walk through the field to get to Canyon Ln from the bike path (which traverses from the Zoo to Beaverton) on Pointer Road. Pointer Road is more a bike and walking path than a vehicular road with only resident vehicles utilizing it....(more below).

I want to express a deep sadness and disappointment that THPRD is proposing an extensive playground and not a natural area park & garden. Those of us who live in this neighborhood have had several meetings with THPRD and participated in their so-called surveys for the design of the green space. In short, THPRD is pushing through an overdeveloped PLAYGROUND, and not the green, garden-like space that I and all of the neighborhood have been advocating and voting for. Our wishes fall on deaf ears at THPRD. Their budget is not available for any of us to study, and the plans for this playground they are pushing through are a ridiculous excess that the neighborhood has no need or desire for. We have a lovely, quiet, neighborhood greenspace and want to keep it that way! It's smart and economical! Two things we neighbors feel that THPRD representatives we've worked with are not...

There are three school playgrounds within walking distance of this neighborhood, so why is THPRD pushing a playground with a water feature, a covered picnic area, playground equipment, etc., and CUTTING seven trees to do it?

None of us understands why they are doing this!! If what they propose goes through it will draw bad foot traffic off of the bike path and create crime and vagrancy in our peaceful, safe, and secure neighborhood!

Why haven't we stopped this yet? Because THPRD representatives do not and did not listen to the majority of neighbors and other interested parties when we told them over and over again - to keep it simple, economical, garden-like, natural, green, and quiet.

So, you at the City are our last resort- please let's take a pause here and look and the impact to the bike and foot traffic along Pointer Rd. which currently has only neighborhood vehicular traffic (three families, six vehicles- and the occasional Amazon or other delivery vehicle).

The effect a 'development' such as this will have on the neighborhood safety and serenity cannot be overlooked or overstated. We fear that we will be policing the playground which will result in calls to the Beaverton Police- an already busy force mitigating houseless and ill people on the streets.

Finally, what's this costing government and taxpayers? Sure, we just passed another round of funding for THPRD, but that doesn't mean they get to push through expensive and unneeded developments such as this.

Bottom line - this is not what the neighbors wanted and THPRD has not listened to us. WE WANT A PARK AND THEY ARE PUSHING A NEEDLESS and EXPENSIVE PLAYGROUND on us.

Thank you for your time and attention to our neighborhood and to the greenspace.
