SUBJECT: LU32024-00057 Fred Meyer Walker Road Wireless Facility

This memo in intended to supplement the staff report dated July 17, 2024, and the supplemental memo dated July 23, 2024, for the proposed LU32024-00057 Fred Meyer Walker Road Wireless Facility project (WF32024-00056). This project is scheduled for Planning Commission hearing today, July 24, 2024.

This memo identifies corrections to the findings for Wireless Facility Three approval criterion 40.96.15.3.C.10 and the associated code conformance chart for Chapter 20 compliance. Deletions are shown in strikethrough font. Additions are underlined in red. The corrections do not affect staff's recommendation of approval for the proposal, subject to conditions.

Section 40.96.15.3.C.10

The proposal is consistent with all applicable Site Development Requirements of Sections 20.05., 20.10., 20.15., 20.20, and Section 70.15 of the Development Code unless the applicable provisions are subject to an Adjustment, Planned Unit Development, or Variance which shall be already approved or considered concurrently with the subject proposal.

FINDING:

The applicant states the proposal is consistent with all applicable site development requirements of Development Code Chapter 20 (Land Use). Staff cites the code conformance chart herein, which shows compliance with the applicable standards of Chapter 20, consistent with this approval criterion.

Conclusion: Therefore, staff finds the proposal meets the criterion for approval.
